Suggested Safety Activities

The list of activities are only <u>suggestions</u> and can be modified. Localized activities, meeting the needs of your facility, are strongly encouraged.

Activity	Duration: 30-60 minutes
Test fire extinguisher skills, train	30 minutes, per shift
Teach emergency response	30 minutes, per shift
Tabletop emergency response activity	30 minutes, per shift
Safety vendor fair (displays)	30 minutes, at lunch breaks
Practice LOTO – Review of training	30-60 minutes, per shift
Practice fall protection/rescue	45-60 minutes, per shift
Safety swaps	45-60 minutes, per shift, by area

Activity	Duration: 1-2 hours
Review facility/machine PPE requirements and fit employees for PPE	1-2 hours, per shift (depending on # of employees)
Review basic first aid	1-2 hours, per shift
Mini 5S blitz (spruce up common areas)	1 hour, per area

Activity	Duration: 3-4 hours to ½ day
AED/CPR training (group training)	Up to 4 hours
Hearing tests (offered during lunch)	Up to 4 hours, total (individual test may take 10-15 minutes, each)
Vision test (offered during lunch)	Up to 4 hours, total (individual test may take 10-15 minutes, each)
